RULES AND REGULATIONS

I. **SUBJECT MATTER AND DATE**

- 1. The 17th Raj Anand Moot Court Competition is based on Indian Science including inventions and innovations uniquely originating in India.
- 2. The Competition will be held on August 26, 2023.
- 3. This is not a traditional moot court and no moot problem or compromis will be released.

II. LANGUAGE

The language of the competition shall be English.

III. ELIGIBILITY

- 1. The competition is open for students who belong to teams that have been invited by the organizers, in accordance with these rules.
- 2. The participants should be pursuing their Bachelors' degree in law i.e. 3 years LL.B. Program or the 5-year B.A., LL.B./ B.B.A., LL.B/ BSc. L.L.B Programme, as on the date of the competition, i.e. August 26, 2023.

IV. **TEAM COMPOSITION**

- 1. The teams should consist of precisely two oralists and one researcher. Only the two oralists are permitted to make the presentation.
- 2. The researchers are not allowed to speak unless a question is specifically posed to him/her by the Judges.

V. THEME OF THE COMPETITION

- 1. The theme of the competition encompasses <u>inventions and innovations uniquely</u> <u>originating in India in any period</u>, including but not limited to the British, the Mughal or even the pre-historic period.
- 2. By way of illustration only, the participating teams may choose either of the following topics for their presentation under the aforesaid theme:
 - i. Food.
 - ii. Lifting, moving, pulling appliances, machines, methods, or concepts.
 - iii. Transporting, communicating, navigating, packing appliances, machines, methods, or concepts.
 - iv. Keeping the environment clean, purifying, etc.
 - v. Health and Medicine
 - vi. Agriculture
 - vii. Building
 - viii. Music and Musical Instruments



- ix. Amplification means or means to improve visibility or circulation of anything.
- 3. Please note that the aforesaid topics are only illustrative and the participating teams may choose any other topic under the theme mentioned hereinabove.

VI. REGISTRATION / INTENTION TO PARTICIPATE

- 1. Teams may register for the competition by filling the registration form, as shared on email with the present rules.
- 2. There is no limitation of the number of teams participating from each college.
- 3. The last date to register/ indicate your intention to participate is April 10, 2023, 11:59pm IST.

VII. SUBMISSION OF SHORT PROPOSAL

- 1. The interested teams are required to share a proposal of not more than 300 words describing the invention.
- 2. The said proposals will be shared over email on the moot court ID, i.e. mootcourt@anandandanand.com .
- 3. The last date to submit the aforesaid proposals is April 30 May 14, 2023, 11:59pm IST.

VIII. SELECTION OF TEAMS

- 1. On the basis of the short proposals submitted by the teams, ten teams will be selected.
- 2. The decision regarding the selections will be communicated to the respective teams over email by midEnd-May, 2023.
- 3. The aforesaid email will also indicate the team code allotted to the selected team.

IX. SUBMISSION OF DETAILED PROPOSAL

- 1. The top ten top 21 shortlisted teams will then be required to submit a detailed proposal.
- 2. The following requirements for proposals must be strictly followed. Non-conformities will be penalized:
 - The teams must e-mail the final proposals to the organizers to mootcourt@anandanand.com by 11.59 P.M. IST on July 1 July 15, 2023 in MS WORD format only.
 - ii. 3 hard copies of the proposals must also reach the organizers by the July 15, **July 24, 2023**, latest by 5.00 P.M.
 - iii. Once the proposal is submitted, the teams will not be allowed to make any amendments to the same.
 - iv. The proposal must be
 - On A4 Size Paper
 - Printed on both sides
 - Bookman Old Style, Size 14
 - 2 line spacing
 - A margin measuring one inch on all sides of each page.
 - Page numbering should be at the bottom centre of each page.
 - v. The proposal must be spiral bound. (Teams are requested to minimize the use of plastic. Innovative methods will be awarded an extra point.)



vi. The memorial must necessarily contain the following sections and must be restricted as stated below:

- vii. No additional sections may be incorporated or relied upon other than those stated above.
- viii. The teams are advised to use The Harvard Blue Book Style of footnoting as far as practicable. In any case, footnoting styles must be consistent throughout the memorial.
- ix. Footnotes must be restricted to providing bare citations, and must not be accompanied by any form of description or explanation of the authority relied upon.
- x. Footnotes must be:
 - Bookman Old Style, Size 10
 - line spacing

X. SCORING CRITERIA OF DETAILED PROPOSALS

1. The criteria for scoring of the detailed proposals along with the breakup of the marks is as below:

a) Identification and presentation of issues	25 points
(Comprising the preamble, background and the objectives of	
the invention, as referred hereinabove)	
b) Manner and style of description of invention	30 points
(Comprising the description of the invention and the	
participants' take on the invention as it exists today, as	
referred hereinabove. Teams have the liberty to provide their	
perspective on the usefulness/ patentability of any other views	



on the invention. This section will evaluate the team's ability to communicate the nature of the invention, their research and storytelling skills)

- c) Use of authorities and precedents
- d) Logical structuring, Grammar & Style

e) Consistent footnoting & formatting

X. PRESENTATION

- 1. The selected teams will also be required to prepare a PPT presentation, based on the detailed proposal.
- 2. The presentation must be emailed to the organizers to mootcourt@anandanand.com by 11.59 P.M. on August 1 August 6, 2023 in MS Powerpoint and PDF format.
- 3. Once the presentations are submitted, the teams will not be allowed to make any amendments to the same.
- 4. The presentation must adhere to the following formatting requirements:
 - Bookman Old Style, Size 28
 - Slide number should be at the bottom right of each page.
- 5. The presentation must not mention the name of your institution or identify the participating college or student in any manner. Teams are required to only mention the team code provided on the top right-hand corner of the first slide.
- 6. The presentation must not exceed 15 slides.
- 7. The presentation must not be beyond the scope of the detailed proposal.
- 8. Each team will get 30 minutes 15 minutes to present their project on the 26th of August 2023.
- 9. The competition would take place at the India Habitat Centre starting at 10:00 AM. Detailed itinerary regarding the event will be released by **August 12, 2023.**
- 10. The participants need not have a science background, but good research, presentation, and storytelling skills, which is what they will be judged on.

XI. SCORING CRITERIA FOR PRESENTATIONS

1. The criteria for scoring of the presentations along with the breakup of the marks is as below:

2. There will be a cash prize of INR 2, 00, 000 for the Winning Team and INR 50, 000 for the Runner-Up Team

3. Each of the remaining 8 19 selected teams will receive INR 10,000 for all the efforts put in.
